### **WP 1.4 Technology Roadmap, Focus group, resources and leadership (Roberta)**

One of the main difficulties is the insufficient Person Month allocated to achieve the tasks  
 To that respect Alain Leger reminded that in January Univ Trento and Industry Area manager made a strong CFP, with a result of few participation to the WP 1.4. At the Hanover meeting, Alain Leger clearly voiced this concern to the PMB and decision from the Director was to keep the resources in Industry as it is in the contract (globally).  
 The Area managers will take action towards partners and EPMB to resolve this lack of participation in industry

Roberta presented the methodology they propose for helping in structuring the Roadmap  
 This consist mainly in the application of two technics

- Focus group
- Delphi methodology

Alain Leger will start a first tentative draft of the Technology Roadmap based on the Agent Link one and other excellent ones found in NLP as good examples. And distribution of effort in KW and with the support of the Industry board will be sought.  
 Alain Leger gave the recent new draft of the Agent Link III Roadmap to Univ Trento.  
 Alain Leger remind that we have 4 months for issuing a first initial draft of the technology roadmap.

Univ Trento and FT will work closely on that issue

### **SWF Requirements and Architecture (Wolf Siberski)**

Asun and Wolf had a diverging understanding of the goal the task. So during the Teleconference, Asun made it clear what she is expected from the task.

Asun has explained her vision that is related to set the requirements for interoperability and not to the development of a software framework.

This will be reflected in the new D 1.2.2 (M21) and first evaluation in the D 1.2.4 (M 24+)
